
As part of the standard review process communicated through the Divisional Officer WHO and EPI Coordinator, the performance evaluation of the GAVI-CDS-supported vaccinators was submitted to your office. The evaluation revealed that 09 out of 17 vaccinators did not meet the benchmark indicators.

An internal meeting was convened to review the matter, and it was unanimously decided to provide these vaccinators with an opportunity to improve their performance. Considering this, it is recommended that the contracts of the following vaccinators be extended on a probationary basis:
