#### Job Description and Responsibilities:

#### 1. Pre Campaign:

Micro-Planning: - Assist in preparation and updating SIA micro-plan. Validate the micro-plans in the field. Help in identifying and mapping high-risk areas in the specific UC.

Assist in selection of appropriate vaccinators as per given criteria and in their distribution as per need. Assist in the monitoring of timely distributions of DDM cards. Ensure that cards are filled properly and upon completion of campaign their submission to the provincial office for further processing.

Follow up and report to Immunization Officer on timely payment of incentives to the frontline workers. Trainings: Assist the Immunization officer, and district trainers in planning, coordinating, and organizing training sessions for vaccination teams and supervisors.

Partnership and coordination: Promote partnership with all influencing factors at UC level in support of SIAs.

#### **Campaign Implementation:**

Monitoring: - Monitor the process of implementation of the campaign as per guidelines and provide feedback to DPEO.

Data Collection & Analysis: - Collect and collate the tally sheet data from the area of responsibility on daily basis. Ensure proper implementation of SIAs with special attention to hard-to-reach areas and under served high risk populations.

Attend the daily evening review meeting at UC level for every SIAs and record the findings/observations for corrective action on the following day of the campaign.
