Regrettably, Chw Shabana is expected to be unable to perform her duties for approximately 2 months.

It's important to note that this incident occurred while Chw Shabana was not engaged in any field activities related to our polio program. Therefore, we believe that She is eligible for coverage under insurance policy, which provides benefits for off-duty accidents.

We kindly request your prompt review and processing of this claim to ensure that she receives the necessary support and assistance during this challenging time.
