He was initially taken to DHQ hospital Nassirabad from where he has been referred to Chandka medical hospital Truama Center larkana in serious condition . Being supervisors and AC of division , I am continuously in touch with the family , and update the office on each moment . For now you are requested to plz inform third party officials and as per officials SOPs .
