1. Through this application applicant seeks his appointment as the guardian of the person of the minor Dua.

2. It is maintained that applicant is maternal grandfather of minor. Liaqat Ali and Anam the both parents of minor passed away due to explosive of gas leakage on 04.03.2025. In this regard a report vide Marasla No.55 dated 04.03.2025 was also filled in the Police Station Brewery Road Quetta. The maternal grandfather also passed in an incident. Now minor is residing with applicant, who is looking after all her day-to-day affairs. While for the procurement of their legal documentation Guardianship Certificate is required. Hence the application.



F.	Whether a guardian of the person or property or both of the minors have been appointed by any person entitled or claiming to be entitled by the law to which the minors are subject, to make such appointment.	No.
G.	Whether an application has at any time being made to the court with respect to the Guardianship of the person or property of the minors and if so, when, to what court with what result.	No.
H.	Whether the application is for the appointment or declaration of a guardian of a person of the minors or of their property or both?	Appointment of the applicant as guardian for person.
I.	Where the application is to appoint guardian, the qualification of proposed guardian.	The applicant is real maternal grandfather of the minor, hence he is entitled for grant of guardianship certificate.
J.	Where the application to declare a person to be a guardian, the ground on which the person claims.	Yes being real maternal grandfather of minor, the applicant is looking after and managing all the affairs of the minor, including health, boarding, and other prompt decision so required for the better welfare of the minor.
