Jinnah Hospital refused treatment due to which she had to be taken to Agha Khan Hospital. Now CHW Naeema has been shifted home from Agha Khan Hospital after treatment. As CHW Naeema's financial conditions are not good, I request you to provide financial support to CHW Naeema from the Organization so that the loss of CHW Naeema can be redressed to some extent. CHW Naeema is currently on bed rest and not able to work in the field. It is hoped that CHW Naeema will soon be able to play her role in eradicating polio from Pakistan again.

Earlier today, during the morning briefing at the center, Naeema suddenly experienced a severe headache and collapsed. Immediate action was taken, and she was swiftly transported to a nearby hospital. Unfortunately, her condition worsened, prompting the medical team to recommend her transfer to Murshid Hospital, where she was diagnosed with a brain hemorrhage.

As Naeema's first-level supervisor, I am applying for her leave of at least 3 days to facilitate her recovery. I kindly request your understanding and approval of this application.
