I hope this message finds you well. I am writing to report an unfortunate incident involving one of our dedicated community health worker during fieldwork for the ongoing polio campaign.

An incident occurred with CHW Fozia during work; she fell into a sewerage main hole outside the house while door marking and sustained severe injuries. She has been referred to RHC Rehri. She is not able to continue her work for couple of days.

Given the critical nature of the ongoing polio campaign and the crucial role plays in it, I kindly request your support in arranging for a temporary replacement for the upcoming four days. This replacement will ensure the seamless continuation of essential duties and responsibilities during Fozia's absence.
