This letter should be considered as a firm offer of employment with the following standard, non-negotiable terms of employment;


- Gross salary including all allowances of PKR. 55,440/-per month subject to withholding tax.


The formal employment application form and employment contract will be sent to you upon acceptance of the offer letter. You are requested to provide your residence certificate within a month after you commence employment.
