





Employment Contract

THIS AGREEMENT made as of November 23rd, 2022, at Islamabad between CHIP Training and Consulting (Pvt) Ltd (hereinafter referred to as Employer) having its principal place of business at Islamabad and Mr. Muhammad Jabran (hereinafter referred to as Employee), 10041035 -Yumna Filling Station - Lahore - Punjab. WHEREAS the Employer desires to obtain the benefit of the services of the Employee, and the Employee desires to render such services on the terms and conditions set forth.

IN CONSIDERATION of the promises and goods and valuable consideration the parties agree as follows:

1. Position Title

- (a) The employee shall be designated as a **Safety warden** for the bike straddling project.

2. Contract Validity
