

Consultancy Agreement

THIS AGREEMENT made as of April 04, 2023 at Islamabad between CHP Training and Consulting (Pvt) Ltd (hereinafter referred to as "Consultant") having its office at Sector 10, Phase 1, Sector 10, Islamabad and Mr. Qazi Nasir Ud Din (hereinafter referred to as "Consultant"), Dera City III - Dera Ismail Khan - D/ Khan - KPK.

IN CONSIDERATION of the premises and goods and valuable consideration the parties agree as follows:

1. Position Title

- (a) The Consultant shall be designated as **Provisional Scholar Task Force Member (PSTM)** for Paho Third party personnel (PTPP), on behalf of the United Nations Development Program (UNDP) in Pakistan.

2. Agreement Validity

The Consultancy Agreement shall be valid from April 04, 2023 to June 30th 2023 and shall be considered discontinued if not extended expressly.

3. Duty Station & Reporting Line

The Consultant shall perform his duties in Dera City III - Dera Ismail Khan - Dikhan - KPK and shall be working under the supervision and guidance of the National Islamic Advisory Camp (NIAC).

- (a) Gross salary inclusive of communication and travel allowance of PKR 31,218/- per month shall be paid subject to withhold tax.

- (b) The employee shall be entitled for PCTB benefits. A contribution shall be deducted from the salary on monthly basis and deposited by CHP along with insurance fees contribution as per rules of client, otherwise employer will not be liable to settle the claims.

4. Remuneration & Benefits

- (a) Gross salary inclusive of communication and travel allowance of PKR 31,218/- per month shall be paid subject to withhold tax.

5. Notice Clause

- (a) Both the Contractor and the Consultant at any time terminate this consultancy agreement by giving prior notice of not less than 15 (fifteen) days in writing, which may be accepted in form of the notice provided.

6. General Terms of Consultancy

- (a) During the course of the Consultant's period of engagement in its termination, the Consultant must observe strict confidentiality regarding matters which the Client wishes are to be treated as such.
- (b) In case of any dispute/disagreement, the contractor is situated within the jurisdiction of Islamabad will have exclusive jurisdiction to adjudicate the matter.
- (c) The Contractor reserves the right to unilaterally alter/modify from time to time the terms and conditions of the Consultant's Agreement and such a variation can take effect without notice.
- (d) This consultancy agreement contains the entire agreement between the parties and supersedes all prior agreements with respect to the subject matter. In event
