However, it will be the choice of a candidate whether he/she appears for improvement of marks in any subject/s or Part I or Part II or as whole with the condition that the candidate can avail these four chances mentioned above till the improvement of the actual result within three years. Once the result of the candidate is improved, he/she will not be allowed to appear again. However, the candidate appearing to improve their overall Grade "E" or "D" are allowed to avail four chances within three years till the achievement of overall Grade "C" (50% marks).
 - (vi) Other rules of improvement currently in vogue in all Boards of the Punjab will remain the same.

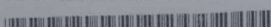
