Before the investigation, the complainant refused to give any written/verbal statement regarding the complaint. Therefore, PE team conducted a session on harassment with all UC staff.

Then individual meetings with female staff were carried out by both CTC and PE female staff in order to record the complaints/grievances if the female staff members are facing. However, no female staff member reported any issue related to harassment or abuse of authority. The PE grievance officer also shared her mobile number with all UC female staff, to call her if they are being harassed or facing any issue from their supervisors.

The case may be considered closed without taking any further action.
