A thorough investigation into the allegations was conducted at the DEOC on 4/2/22. The UCPO and TCO Bakht Naseer (accused) were called over to the DEOC in presence of DCO Mr. Rooh UI Amin and Immunization Officer Dr Maheen.

On submission of UCPO Musfira following individuals were also interviewed.

- 1. Master Trainer Adil (in person)
- 2. Shoaib UCOO UC 3 Islam Nagar (on phone)
- 3. Shujaat UCOO UC 4 Nai Abadi (on phone)
- 4. Rabia UCPO UC 7 Muhajir Camp (on phone)

CONCLUSION:

1. In context of the email, all the allegations levelled lack objectivity in terms of date of occurrence and place etc.

2. The DEOC team (myself and Dr Maheen-IO) have concluded that the allegations of "Immoral allegations,

Personalization, Degradation and Favoritism" could not be established and hence are considered false.

3. The UCPO has a history of creating conflicts as raised previously. She has been called to the DEOC for the same and by the CTC for counselling.

4. In response to a previous email received from the UCPO subjected "Unprofessional behavior of TDOSO" on 7th December 2021, the UCPO was advised not to pass judgments and leave the same for the DEOC and admin supervisors. However, the advice was neglected and the same has been repeated in this instance.

4. As the 2nd level supervisor, I recommend that disciplinary action may be initiated against the UCPO as her constant issues are compromising the working environment of her assigned UC. Moreover, the repeated nature of the issues is wasting time of the DEOC team, which could have been utilized in more productive assignment.

5. The counselling session at the CTC and at the DEOC has not had any apparent impact on the UCPO's behavior.

RECOMMENDATIONS:

- 1. It is recommended that the UCPO be issued a final warning.
- 2. Any future actions of this nature should be dealt with discontinuation/termination of contract.
