Dear Madam

This is to report an incident happened today dated 18<sup>th</sup> Jan 23 on SGD Ittehad Town at 11.20am. 6 PTI members names mentioned below came to fight IO against a CHW Saima`s transfer from TSC SGD Ittehad town to SGD M.khan.

Background:

On Monday I have received a written complaint about CHW Saima working as polling agent in Jan 2023 Elections from PPP UC President along with a threat call that if polio staff will work against their party, they will block the area in campaign. The case of not following SHMA policies and working in election without SHMA permission was reported to DDPO for further guidance. She asked to submit the admin case to SHMA in next batch. Meanwhile, for the purpose of CHW`s own security she asked to change her TSC to avoid any political conflict.

Today morning when I called her for change of TSC she has brought these 6 PTI members who gave this matter a political aspect accusing that the decision is made on behalf of political party. They openly threatened me to cause physical harm. They also threatened to boycott upcoming Polio campaign and area blocking.

I tried to resolve the matter, mentioned CHW is reverted to her previous are of work and plan to discuss the case in next admin case meeting in DEOC to follow organizational guidelines. Even then the case was not rested, they all demanded that no action should be taken and they will take the matter in their hands.

Keeping the above and ongoing previously reported security concerns, I absolutely do not feel safe in this working environment and request to be relocated as soon as possible which is now crucial for my own safety
