Subject: Statement

Respected Sir/Madam,

I am writing this official correspondence to categorically reject each and every accusation that has been levied against me. I maintain my integrity and emphasize that I have conducted myself in accordance with the ethical standards and professionalism expected in my position. It is important to note that these allegations hold no factual basis and are unsubstantiated. I hereby provide an official written statment regarding the allegations made against me:

Attendance Issue:

It has come to my attention that there have been concerns raised regarding attendance. It is alleged that the Area Supervisor marked attendance in the Attendance Register of the Community Health Worker (CHW). I would like to clarify that a coordination meeting was conducted with UC Officers, during which a task was assigned to Riffat ucdo. Riffat ucdo arrived early to the UC. This matter is currently under investigation. Two Area Supervisor arrived late but falsely marked their attendance early. Additionally, one Community Health Worker (CHW) arrived at 10:15 am, yet falsely recorded their attendance at 9:40 am. The written statement addressing this matter was enclosed in the email earlier.

On 16 May 2023, while conducting morning discussions at BHU, an unfortunate incident occurred involving Naila, the Area Supervisor. She fell down before the morning assembly, requiring immediate medical attention. The incident was promptly reported to the Dr Faisal Javed (UPEC), who subsequently notified the appropriate authorities.

Emergency services were contacted, and Naila was swiftly transported to the hospital by the 1122 helpline. A visit was made to City Hospital to follow up on Naila's condition, accompanied by UCO Mushahid Ullah. At the hospital, AS Haseena, Ishrat, Kainat, Irum Bilal, and Shaheen, along with the People HR team, were present.

In light of the situation, all the Area Supervisors (AS) were informed to proceed to the field. They acknowledged the instructions and expressed their compliance. UCDO Sidra and Haseena remained at the hospital to provide support to Naila during her stay.nUCDO Sidra and UCPO held meetings with Mehreen from the EPI City Hospital to seek assistance in the hospital. They also met with Himayat PTP worker to request additional support in this matter.

Additionally, there was a requirement for Afghan data on the same day. UCDO Riffat and I personally attempted to contact the Area Supervisor via phone. Unfortunately, the calls went unanswered. UCDO Sidra was also contacted but was unable to respond at that time.

Following this, another visit was made to the hospital, where UCDO Sidra, AS, and I were present. I, telephonically contacted Sir Arbab Bilal, Sir Co-ERU, and

discussed the issue with him. During the conversation, UCDO Sidra informed us that the Area Supervisors were considering resigning from their positions. Regrettably, due to this situation, the data for Hazar Khuwani 2 was late on the same day.

AS and ALSM Training:

Regarding the AS and ALSM training, I would like to address the concerns raised. It is alleged that proper training was not conducted and that the session was merely a formality. During the training, a table discussion began, but an issue arose between UCDO Riffat and Sidra, leading to an argument. The training was temporarily paused and the individuals were instructed to resolve their arguments. Additionally, it was brought to my attention that money was being collected for refreshments, which caused further disruption. The training was eventually resumed after the refreshment break.

Allegations of Team Restriction:

I categorically reject the allegation that I restricted any team or hindered their work. It has been claimed that I denied permission to a team member, resulting in her miscarage. I firmly deny this allegation and assert that I did not take any such action which would result in such a mishap.

Alleged Uncomfortable Behavior:

I also reject the accusation that I engaged in behavior that is 'staring' which made teams feel uncomfortable. I firmly deny any action that could be interpreted as such.

Allegation of Physical Contact:

Lastly, I refute the claim that I touched a team member's arm. I strongly deny this allegation and affirm that I did not engage in any such behavior.

I request a thorough investigation into these allegations. I am fully committed to cooperating with any inquiries or procedures that may be conducted in order to resolve this matter effectively. Thank you for your attention to this matter. I kindly request that this official rejection of the allegations be duly noted and taken into consideration during any further proceedings.
