On June 3rd, while I was diligently performing my data analysis duties, I began to hear a loud conversation filled with laughter. Initially, I tried to ignore it, but it continued to disturb and irritate me so I laid down to check where found TDOSO Tauheed with Azeem UCOO, Javeria UCPO, Rehman UCOO, Nabeel DEO, Hamid ex-TSV, Zara ALSM UC were engaged in spreading baseless gossip and discussing personal affairs related to UCPO lqra with various individuals, which I heard by standing beside the door for 10 mins, where everyone had trying to artifacts the stories with charchter assignation along with plan to downgrade infornt of my husband where Hamid was telling as I am best friend of Rameez (my husband) The main culprits behind these disrespectful conversations were TDOSO Taheed, Ucpo Javeria, Hamid, and Nabeel, who were not only indulging in inappropriate behavior but were also conspiring to fabricate false stories about me to disrupt my married life. Shockingly, I managed to capture evidence by taking snapshot the UCOO Azeem attempting to snatch my mobile and trying to physically harm me.
