So based on his unprofessional behavior and not reporting an issue to the next level Warning can be issued to him. Furthermore counselling session can be done for him and he can be relocated to another UC

In addition to that he should be kept under observation for next 3 months, during that period if any evidence supporting harassment claims comes then his services can be terminated

Dear Dr. Saifullah Khan,

I hope you will be doing well. A couple of serious Sexual Harassment complaints have been reported against Mr. Fahad Zaman UCPO-University Town, District Peshawar by the CHW's. In order to probe the matter, PE team jointly with CTC team conducted a fact-finding investigation of the matter on 9th and 15th June 2023. Individual meetings with the field staff members were conducted in the PEOPLE's office to acquire their statements. The Conclusion and Recommendations of the Fact Finding Committee are as following.

## Conclusion:

- Based on the findings of the investigation, it can be concluded that UCPO Mr. Fahad Zaman mentally tormented staff, treated them disrespectfully, and threatened to send emails against them. Many staff members are afraid of him due to concerns about job security. The work environment at UC is unsupportive for female workers and Mr. Fahad has been involved in the harassment of vulnerable and weak female employees.
- The Fact Finding Committee is convinced that the complaint was accurate and the individual in question admitted that he did not follow the proper protocols for reporting incidents to superiors. It was also observed that UCPO Mr. Fahad Zaman lack awareness about his TOR's. Furthermore, a concerning change in the body language was exhibited by the UCPO while discussing the subject matter.
- UCDO Ms. Farah Ambreen demonstrates weak supervisory skills and consistently supports UCPO Mr. Fahad Zaman in every situation. Consequently, the staff members hesitate to share any problems with her as they know she will share everything with UCPO Mr. Fahad Zaman.
- During the investigation, the fact finding committee came across a complaint filed against CHW Nazo, accusing her of accepting money from members of the community without providing reimbursement, thereby demonstrating unprofessional behavior.

## Recommendations:

• The Fact Finding Committee has recommended the Termination of UCPO Mr. Fahad Zaman from the Programme on account of Professional Misconduct. (Moral and Sexual Harassment).

• A Warning is recommended against UCDO Ms. Farah Ambreen as she is involved in professional negligence to the duty and she lacks supervision qualities.
A detailed Counselling Session is recommended for CHW Ms. Nazo.
