After which Asma prepared a letter on the next day to prepare a case of harassment against me, which was to be signed by Javed Khan, but Javed Khan completely opposed this type of activity.

On which Javed Khan sent me the entire incident in writing that is attached.

Note: I demand that this kind of inquiry should be resolved with transparency.
