Reference to below complaint forwarded by AC Peshawar and lodged by local community at DHO Peshawar office regarding the alleged use of Govt premises (BHU) for illicit activities at UC Haryana Payan, a preliminary assessment of the complaint was done and attached herewith for your kind review and further necessary advice.

The complainant has leveled serious allegations against the CBV staff and accused them of involvement in unethical and immoral activities. The earlier complaints (attached for reference) also indicate that the UCPO Ishaque and UCOO Sheryar were giving favor to CHWs and misreported their field presence. Moreover, UCPO Ishaque has been reported for abusive behavior as well.

Considering the previous complaints against Ishaque and Sheryar, it is suggested to conduct a thorough investigation into the allegations to ascertain facts and hold the staff accountable in case they are involved in immoral activities.
