- a) UCPO asserts that if a family initially refuses but later agrees in the same visit, the child is considered vaccinated.

- b) In contrast, UCCO contends that such cases should be recorded as refusals to maintain an accurate advocacy record for future.

The internal disagreement among UC officers appears to have contributed to the issues in question. Please share your feedback regarding the matter.

We came to know that on the 4th day of the campaign, a house was visited by CHW (Sher Bano) that was locked in the morning, as per practices this house should be counted as N/A house,

On the same day, the ALSM visited the same house and found the door open and that family refused vaccination due to back-to-back campaigns, but the ALSM was successful in convincing them and covered the children on the same day,

in this scenario, the family will be counted as a refused family instead of N/A.

The case was discussed in the evening meeting by the officers of the UC level, and all agreed that this matter was closed, The HR team came to know about the misbehavior of UCPO Iftikhar with staff and tried to pressurize them which can create more problems in upcoming days and their teamwork will be affected.
