The whole plan was ^⑤ decided at the house of Dr. Musharraf's house in 4-13. Mr. Abrar came ~~back~~ very late to his house. Discussed all matter with his mother. ⇒ Miss Fehmeeda Ex-TUSP F-8 sent a complaint against Dr. Musharruf to WHO in last Campaign. Some colleagues discussed with me that Dr. Musharruf and his group are saying that Mr. Harris Sultan TPO is supporting Miss Fehmeeda. I have seen all the evidences against me and i am concluding from it that Dr. Musharruf and his group of UCPOS, and TPO mentioned above are doing all this against me.

This complaint is linked with Email against EX-DHCSO-CDA Mr. Hassnat and the Complaint sent by Miss Fehmeeda Ex-TUSP and UCMA-F-8 in last December Campaign.

- There is a group work of Dr. Mushraf behind all this. Complaint of Showcause.

⇒ Till end of this investigation i was not clear about alligations. At the end i am Concluding that Dr. Mushraf provoked Me through Ghulam Mustaf (TSA-CDA). Along with this he shared a screenshot approximately one year old. Ghulam Mustafa contacted me many times and talked against Ikram-TPO to show me that he dont likes him. He called me many times to complaint about Ikram-TPO that he is highly improfessionel with all staff.

⇒ In last in Concluded that Same group Under the Umbrella of Dr. Mushraf did what they already done with Mr. Hasnat DACSO-CDA. For Hasnat they had collected many proofs. But against me they utilized Screenshots of Ghulam Mustafa (TSA-CDA) and Dr. Mushraf one year old conversation.
