- ⇒ In last i concluded that same group under the umbrella of Dr. Musharraf did what they already done with Mr. Hasnat DACSO-CDA . For Hasnat they had collected many proofs . But against me they utilized screenshots of : Ghulam Mustafa (TSA-EPA) and Dr. Musharraf one year old conversation Hasnatullah (10/10) TPO-CDA
