Subject: [EXT] Involvement of Impersonator in field

Dear Sir,

I trust this communication finds you well. Today, while conducting follow-up visits on Catch-up Day 1 (NID-Nov 23) in UC Khalisa-2, Area Latif Abad, I encountered a grave operational issue that warrants immediate attention.

During my field visits, I observed an individual impersonating a health worker in collaboration with security personnel. This person equipped with chalk, was swiftly marking doors from the outside, without engaging with households regarding the vaccination status of eligible children. Upon further investigation, it was discovered that CHW **Uzma Emp Code 10601845** had enlisted an impersonator, a female worker named Sapna. This impersonator was tasked with marking doors with the current day's codes, while CHW Uzma was preoccupied with other day tasks. Disturbingly, all these activities were clandestine and deliberately kept undisclosed from UC Officers.

Addressing this matter proved challenging, as the impersonator displayed reluctance to leave the area, either due to immaturity or a deliberate attempt to disrupt the program. Despite persuading her to vacate the field, she stayed for approximately 15 minutes with security, seemingly awaiting an opportunity to resume her activities once I departed.

It's noteworthy that CHW Uzma was recently reassigned due to her apathetic work attitude and concerns raised by seniors. On day 4 of the current campaign, one TVBMC reported against her. Additionally, during SNID-Nov 23, a 13-month-old unregistered child was identified in her area, (already emailed to Vendor) further underscoring her lax approach to her responsibilities.

Upon visiting the adjacent Area Wazir Colony, where CHW **Nayab Emp Code 10601867** operates, similar instances of door marking and writing style were noted. Subsequent investigation revealed that the impersonator, Sapna, was the daughter of an aged CHW **Mufida Emp Code 10601876**. Shockingly, CHW Uzma was facilitated Sapna's presence in the field with security, and a similar scenario unfolded in CHW Nayab's catchment area as well.

Importantly, it was revealed that CHW Nayab is also the daughter of CHW Mufida, and she utilizes the services of an impersonated worker, not only for herself but also for her daughter (who works as CHW) and for other CHWs during polio campaigns as well.

The performance of the Concern Area Supervisors (**Mehru Nisa, & Noreen**) has become a cause for serious concern and dissatisfaction, as both individuals have demonstrably failed in their responsibilities to effectively oversee field operations, exercise control, and manage staff.

It is evident from my personal analysis based on today findings that the Concern Area Supervisors were well aware of the ongoing developments. This was not an isolated incident, as the impersonator displayed a high level of audacity. Moreover, it has come to light that the mother of impersonator, CHW Mufida, made repeated attempts to recruit her daughter, as her one daughter already onboard in same UC as CHW.

In light of these findings, I strongly advocate for holding both Concern Area Supervisors accountable for their faults and lapses. Their failure to address such appalling misconduct and violation calls for decisive

action and accountability measures to rectify the situation and ensure the effective management of responsibilities in the future.

I amy request to take an appropriate measures to address these issues promptly.
