

Written Statement

It is to inform you that Dr. Jehanzeb Focal Person (ERU) and my Ex-Deo Dr. Najeeb had some personal issues with each other during his visit of VC Shikoh Jundabad in February 2019. Dr. Jehanzeb asked me that Dr. Najeeb does not visit the VC concerned however you don't inform me regarding this. According to him Dr. Najeeb is disloyal to his duties and not visiting VCs. Later on, Dr. Jehanzeb called me on whatsapp and told me that he will not forgive Dr. Najeeb further he told me to call him back with his required statement i.e. Dr. Najeeb does not visit VCs and whenever he visits he intends to follow the female staff. In response I informed him that this ^{has} never happened therefore I can't state the same. On my this response he abused me and told me that you too have not sound character and dropped the call. The very next morning Dr. Jehanzeb visited my VC Concern VC SJA and told me that you are a liar and Dr. Najeeb is not visiting your VC. Hearing all this VPEC Dr. Usman was not interested to tell Dr. Jehanzeb the truth but on my remainder he told Dr. Jehanzeb that Dr. Najeeb came VC SJA two days ago.

Then on 11 March Mr. Babar bin Ata Focal Person Polio came to EOC Peshawar and after some tough speech between Dr. Jehanzeb and Dr. Najeeb Mr. Babar bin Ata shuffled Dr. Najeeb from Smt Circle to town 4. Then Dr. Jehanzeb called me on my whatsapp and told me that now there is a female VCs in your VC and I can feel that

You are interested in her and now it's your turn to go out from DET Programme. So I immediately informed my new PEO Dr. Shahab.

March Campaign day 5 at evening meeting - ^{5:30 PM} our coverage was low so UPEC Dr Usman told us to go to field and do more coverage as the time was already late and in increasing coverage all AS and CHW got late and came CD on 7:30 PM I quickly compiled data and we all staff left CD at 8:30 PM I informed my PEO and UPEC from all this scenario. On next day morning Nazim Khaid came CD and abused me that why you left all staff yesterday night late then offer involvement of Nazim Shaid Gil, Nazim Mumin, Distt member Wahab Safi, Ferozq Councillor, Warheedullah Councillor the issue solved on the spot.

Here are some points to be clear that Area Supervisor Reema Alam has been reported on regular education and Area supervisor Asma and CHW Rani both were reported to CIC for inquiry by UPEC Dr Usman for false signature on leave application then when they met Dr Jehanzeb they plan a conspiracy against me and UCO Even on continuous absences Dr Jehanzeb awarded both AS Asma and CHW Rani for their best performance and for writing against me and UCO Rida.

On 6th December CIC reinstated me and on 7th December I joined CD SJA then when Dr Jehanzeb came to know that Wasim ^{UCO} is reinstated by CIC he openly told that CIC is not supposed to reinstale someone without my permission and I stopped visiting UC SJA because of Dr Jehanzeb.
