I joined SMT circle Peshawar as PEO in SEP 2018 and was supervisor of Waseem UCPO till March 2019 then moved to Town 4 after I filed complaint against the Deputy Coordinator SMT Circle Dr. Jehanzaib anguish, anger, unprofessional attitude and conducts. The written complaint was taken personal though I documented it for my safety only. Under shadow of district administration started to harm my professional career by collecting lame proofs by provoking staff. In this context Waseem Ucpo was contacted on WhatsApp and instructed that few minutes later I will call from my cell and you have to accept that Dr. Najeeb is involved in immoral activities and not performing his duty to his best. Upon refusal he did same with UCPO Waseem by using the Health facility staff then.

During my tenure as PEO in SMT found Waseem Ucpo well aware of WHO protocols and a helping hand to the UCMO and staff working. His previous supervisors were Dr. Fazel Raheem and later on Dr. Shahab, Dr. Musawir but none has documented anything unprofessional against him ever. Regarding Rida UCCO I'm not in position to comment as she joined the specific UC when I had left.

In the end I will say that hierarchy in his specific case has been totally ignored and influence of local government, District administration has been used with malafide intentions. Among the affectees are multiple partner staff including myself, Dr. Izaz, Dr. Musawir and UNICEF staff Hussain Ali Senna and Shiraz Ahmad.
