Respected Sir/Madam

It is stated that on Friday 17/5/2024 I came to know through my Supervisor (TDO) ^{Robina} that me and UCCO Saqib has been called to DC office to explain regarding an anonymous complaint saying that we keep staff till late time in CD. I explain that our official timings are till 4 PM but we spare staff till 1:30 PM in normal days and during campaign depends on data completion. Then after meeting with Madam Saiba Sofi (ADC). She was busy and told me that you can go now. On same day we discussed the same with operational supervisor Muarrama Shalwal (UCCO). Then today on 30/5/2024 an inquiry teams from CTC and PEOPLE came to CD Zayab Farjibadal and discussed below bullets.

- ⇒ Environment of UC/CD I said good.
- ⇒ Management of UC/staff I said good.
- ⇒ Daily Routine. I said after morning briefing I leave the room where staff sat and I goes to Training Hall with UC monitors.

- ⇒ Timing of duty - 9am to 4pm is official but we spare staff till 01:30pm after completion of daily task assigned by District.
- ⇒ Doubt on any staff member: I said I reported a mixed family in CHW Glazala^{Area} three rounds back and she said in my absence before UCCO and other staff members that I will see you.
- ⇒ So in last campaign SWID April on day 1 I was visiting CHW Glazala Area with UPEC chairman Dr Sumbal, we found a missing child in a house after CHW's visit, CHW Glazala started arguing with me and in start and after when I prove with evidence CHW Glazala started requesting but I reported the issue in ICM cluster to District.

So I joined DEI Programme in 2015 and after 5 years my seniors transferred me from Melal Terai 2 to UC SMT-1 on my performance because SMT-1 was a problematic and low performing UC then after 4 years struggle UC SMT-1 Raised and I request my seniors to transfer me to UC near to my home after my mother's Death.
