Any how before going into detail inquiry the 3rd party female staff should visit and get their field observation, Seek the information of Dr. Arshad / Dr. Younas followed by other FLW and health staff of the BHU and then conduct inquiry.

Pishtakhara is another Politicised and problematic place having too many issues related to working environment having very complex situation. The matter need in depth assessment with few observation of the last inquiry conducted as far I remember:

- 1. He was found very meticulous for improving the SIAs status and having hard stance for documentation and data.
- 2. He was also tough to handle weak FLW force to get work out of him
- 3. Reporting Health Staff for not supporting the activities specially UPEC chairman was arriving quiet late after reporting a group of AICs + CHWs started chanting slogan against him and then inquiry was conducted.
- 4. Looks sterns, rigid, emotional and sentimental by observation may be I am wrong.

I may be wrong for the above at this period of time but Important to mention when he was reported he was not well versed and familiar with the Harassments and other managing working modalities.
