I hope this message finds you well. I am writing to bring it in your attention a serious issue regarding harassment by UCPO Faheem Ali from UC 04, Khokrapar Malir Town.

Recently, it has come to my attention that Mr. Faheem Ali (UCPO) has been persistently harassing our UC 04 AIC, Madiha. He has repeatedly called her and insisted on meeting her at her home late night. Upon learning of this misconduct, I advised Madiha to record his calls for evidence, which she has done, and I am attaching these voice recordings for your review.

As the Town Focal Person, I strongly urge that immediate action be taken against Mr. Faheem Ali. It is imperative that he should be removed from his current position and transferred to another town. Failure to do so may lead to significant difficulties in our upcoming campaigns, as all AICs have expressed their unwillingness to work with him due to his behavior.

I kindly request your prompt attention to this matter and look forward to your swift action to address this issue and ensure a safe working environment for all frontline workers.
