1. Abuse of Authority:

It has been reported that your attitude towards your female subordinates was harsh and threatening. You have abused your authority to such an extent that they were reluctant to testify owing to fears of repercussions. These staff members have confirmed that due to your abusive conduct, a few staff members have also resigned from their position in the past as well.

2. Sexual Harassment

Your behavior towards female staff in the workplace was highly unprofessional and falls under the domain of "Harassment". It has also been reported that you have physically assaulted your female subordinate staff and you have not only created a hostile work environment but also created hardship for those staff who have refused your friendship offers.

3. Financial Embezzlement:

Financial misconduct on payment of Transit Teams was reported against you which highlighted that you used the CNIC copies of your subordinate staff who were already on the payroll of CTC and claimed payment through DDM as Transit and Fixed Site Teams. Furthermore, you forcefully collected charity contribution from all workers in UC to help one of your colleague who was very sick.

4. Non-Disclosure of Kinship:

You got married with Area Supervisor Ms. Zaib ul Nisa and did not disclosed it to CTC, as Ms. Zaib ul Nisa was under your supervision as UC Lead. You also provided favors to Ms. Zaib ul Nisa in her daily attendance and leaves.

Written statement regarding re investigation held dated 20th November 2024

I am writing to formally express my grave concerns regarding the ongoing inquiry into my conduct and the subsequent termination of my services. I firmly believe that these actions are based on fabricated and false allegations. In the interest of justice, I respectfully request that the matters outlined below be addressed promptly.

1. Lack of Transparency and Violation of Constitutional Rights

On 19th November 2024, I was informed of a hearing scheduled for the following day, 20th November 2024. However, the inquiry committee, which consisted of only two members, failed to provide me with any evidence or details regarding the complaint against me, including the identity of the complainant. This omission represents a clear violation of my constitutional right to a fair trial as guaranteed under Article 10A of the Constitution of Pakistan.

2. Absence of Show-Cause Notice and Charge Sheet

Furthermore, I have not been formally issued a show-cause notice or a charge sheet—both of which are fundamental procedural requirements under service rules and regulations. The absence of these documents significantly undermines the fairness of the process and constitutes a breach of established norms. The only document I have received contains vague, unsubstantiated, and fabricated allegations, with no author or issuing authority. This raises serious concerns about the legitimacy of the inquiry.

3. Discrepancies in the Allegation Timeline

On 14th October 2024, during my initial investigation, the inquiry panel presented an allegation of harassment. When I requested the reporting date for this case, Mr. Musal Deen, CTC Federal Official, stated that the case was reported in mid-July 2024. However, I am certain that this date is incorrect, and I suspect that Mr. Musal Deen may have deliberately misled me. I respectfully request that you provide me with the relevant email communications and exact dates regarding when the harassment case was first reported, so that I may verify this critical detail.

4. Introduction of New Allegations In addition, during a verbal conversation on 14th October 2024, when I was initially informed of the inquiry, no allegations were made regarding the disclosure of kinship. However, during the inquiry hearing on 20th November 2024, a new charge, one that had not been previously disclosed, was introduced. The presentation of this new allegation at such a late stage strongly suggests a malafide intention behind the inquiry. Furthermore, the inquiry committee did not provide me with a formal or informal charge sheet, further complicating my ability to defend myself adequately.

5. Unfair and Biased Process

In light of these circumstances, I believe that the inquiry is being conducted with bias and malice, with a clear intent to undermine my rights. The lack of transparency, coupled with the absence of any substantiated grounds for my termination, renders the decision both unjust and invalid.

Request for Reinstatement In light of the above, I respectfully request the immediate reinstatement of my services, as my termination appears to have been executed without due process or justifiable cause. I trust that this matter will be reviewed thoroughly and addressed promptly, in accordance with the principles of justice.

Thank you for your attention to this serious matter. I look forward to a fair and just resolution.

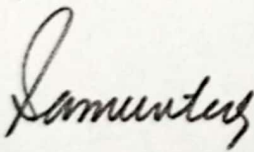

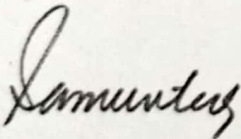

Based on the evidences gathered during the investigation, the findings have concluded that your behavior towards female staff in the workplace was highly unprofessional and falls under the domain of "**Harassment**". It has been found that you have abused few female staff to a great extent that they were reluctant to testify owing to fears of repercussions. These staff members on conditions of anonymity have confirmed that your attitude towards them was harsh and threatening. It has also been confirmed that you have not only created a hostile work environment but also created hardship for those staff who have refused your friendship offers. Due to your abusive conduct, a few staff members have also resigned from their position in the past as well.

You were afforded a personal hearing during the Investigation Process along with the chargesheet. Please note that your defense was carefully reviewed and found unsatisfactory. You have miserably failed to discharge the onus and failed to provide cogent response on the allegations. You are well aware that CTC has a zero-tolerance policy for such behavior which undermines the organizational values for the safety of its staff. Your conduct is in direct violation of organisational policies and warrants strict disciplinary action.

Therefore, in the light of above mentioned circumstances, your employment contract has been terminated with immediate effect; hence making Nov 14th, 2024 your last day of employment with CTC. Please note that the period of your suspension from 17-08-2024 till 14-11-2024 will be treated as leaves without pay. You have already been paid remuneration for 16 days in the month of August, 2024.
