This is to seek your consent on the termination of two UC level staff in Quetta 1. Mr Taymer Mari & 2. Mr Mudasir.

The detail of the issue is as below:

Mr Taymer Mari- UCPO-Quetta was alleged of financial embezzlement, sexual misconduct, and abuse of authority.

CTC has done the detailed investigation of the case and based on the evidences and findings CTC has confirmed that he has violated the SOPs and had been involved in the sexual harassment and abuse of authority.

His financial embezzlement has been confirmed where it is disclosed that Mr. Taymar used the copy of CNIC of Farahana Yousaf / Fazila Nawaz and Bib Arifa CHWs who are already on payroll of CTC, and claimed payment through DDM as Transit and Fixed Site Teams which is confirmed by DDM Finance Team.

All the attached statements and reports indicate his involvement in mentioned acts.

Additionally, during the investigation, it was reported that UCOO Mudasir was involved in the concealment of critical information

- The investigation findings reveal that UCOO Mr. Mudasir ignored complaints of harassment by Mr. Taymer and concealed critical information regarding Mr. Taymer's personal relationships, specifically his marriage to AS Ms. Zaibun Nisa. Statements from Ms. Zaibun Nisa and Mr. Taymer's second wife indicate that Mr. Mudasir was aware of this relationship but intentionally withheld this information from CTC.

- Furthermore, despite receiving complaints from Ms. Zarifa and other staff members, Mr. Mudasir failed to take any corrective action or report these concerns.

In reference to the email below, please find attached the investigation report regarding the allegations against UCPO Mr. Taymer Mari concerning financial embezzlement, sexual misconduct, and abuse of authority.

CTC conducted a comprehensive investigation into these allegations and, based on the findings, recommends the following actions:

The investigation confirmed that Mr. Taymer Mari violated SOPs, including harassment and abuse of authority, with evidence and witness statements substantiating these claims. His actions compromised the safety and well-being of vulnerable staff members and conflicted with the ethical standards expected of someone in a UC lead position.

Therefore, it is recommended that Mr. Taymer Mari be terminated from his position as UCPO, in accordance with the Polio Third Party Personnel Service Rules (PTPPSR), Annex – 7-B: Disciplinary Action in Case of Performance, Table 1: Disciplinary/Accountability Framework/Gross Misconduct - Red Line Area, Sub Clause 6: Abuse of Authority, and Sub Clause 7: Harassment (sexual, discriminatory, workplace, etc.).

Reference to the Investigation Final report and evidences in the attached link <https://we.tl/t-o4qw0WhjbT>, it is evident that the investigation and the Annex provided by CTC are supporting the recommendation and conclusion submitted by CTC.

Following are the brief fact of the case

- The complaint against Mr. Taymar was received from Ms. Arifa, CHW currently working in UC Hazar Gunji, on 26 July 2024, due to which further investigations were conducted including Ms. Zarifa who resigned in May 2024 , she was called by CTC and she recorded her complaint against Mr. Taymar on 29th July 2024.
- As the case proceeded issues such as financial misconduct of payment of Transit Teams was also highlighted , Mr. Taymar used the copy of CNIC of Farahana Yousaf / Fazila Nawaz and Bib Arifa CHWs who are already on payroll of CTC , and claimed payment through DDM as Transit and Fixed Site Teams which is confirmed by DDM Finance Team
- Mr. Taymar also forcefully collected charity contribution from all workers in UC to help one of their colleague who was very sick.
- Mr. Taymar got married with Zaib ul Nisa, Area Supervisor and did not disclosed it to CTC, as Zaib ul Nisa was under direct supervision of Mr. Taymar, he also provided favor to Zain ul Nisa in her daily attendance and leaves
- Mr. Mudasar confirmed that he failed to disclose crucial information and concealed the facts regarding serious issues within the UC .

5. Recommendations: Based on the findings, it has been established that Mr. Taymer Mari has violated the SOP's, including harassment and misuse of authority, which have been supported by evidence and witness statements. Dear Ambrin,

CTC requires approval on recommendations of final investigation report on complaint of Ms Arifa CHW Quetta and Ms Zarifa Ex-AS Quetta against Mr Taymar UCPO Quetta.

On 26th July, Ms. Arifa, a current CHW, filed a harassment complaint against Mr. Taymar to CTC, alleging unwanted advances, deceptive meetings, and financial demands, accompanied by threats to terminate her employment and that of her sister. Ms. Arifa also reported that other current and ex-staff face similar harassment but are unwilling to speak out due to fear of retaliation. Additionally, on 29th July 2024, a former Area Supervisor, Ms. Zarifa, accused UCPO Mr. Taymar of harassment, citing inappropriate advances and pressure to secure her position through personal favors. Despite reporting these incidents to her supervisor UCOO Mr. Mudassir no action has been taken.

Furthermore, The CTC investigation committee has conducted a comprehensive review of the harassment allegations against Mr. Taymar and investigation committee included all the victims and witnesses and Below are the committee's findings. All relevant statements and evidence related to this case can be downloaded from link <https://we.tl/t-GNcKKBNJSW> for your convenience. (link will expire in 3 days).

It is verified from WHO Finance team that payment to three staff is done through DDM in 2023 (email attached). Evidence shows that Mr. Taymar Mari asked them to come to the bank, withdraw the transit team payments, and hand the money over to him. Mr. Taymar has denied this allegation and requested CTC to clarify this matter with the UCMO, claiming he had given the money to the UCMO to pay the transit teams. As CTC's investigation is limited and cannot include statements from the UCMO, the investigation team has asked the Area Coordinator to verify the transit team payments with the concerned UCMO. A response from the Area Coordinator is still awaited.

Regarding Point 1, discussions have been held with WHO-FO, and we will proceed accordingly after receiving their instructions. As Per CTC HO instruction, the complaint will be shared exclusively with WHO-PO and WHO-FO to maintain the confidentiality and security of the complainants.

Additionally, you are kindly requested to review the report and attached evidence related to harassment, misuse of authority, and financial embezzlement, which have been highlighted and pointed out for your convenience.

Recommendations:

Based on the findings, it has been established that Mr. Taymer Mari has violated the SOP's, including harassment and misuse of authority, which have been supported by evidence and

witness statements. His actions have endangered the safety and well-being of vulnerable staff and have gone against the ethical standards expected from someone in UC lead position.

It is therefore recommended that Mr. Taymar Mari should be Terminated from his position as UCPO **“as per the Polio Third Party Personnel Service Rules (PTPPSR) Annex – 7-B: Disciplinary Action in Case of Performance, Table 1: Disciplinary/Accountability Framework/Gross Misconduct - Red Line Area: Sub Clause 6: (Abuse of Authority) and Sub Clause 7: Any type of Harassment (Sexual, Discriminatory, workplace etc.)”**.

Regarding the findings against Mr. Mudasar it has been confirmed that he failed to disclose crucial information and concealed the facts regarding serious issues within the UC. According to Ms. Zarifa’s statement, she reported all concerns to Mr. Mudasar, yet he failed to support her or report these issues. As per the statement of Ms Zaib un Nisa it is also notable that Mr. Mudasar also concealed the fact by not informing CTC about relation of Mr. Taymar and Ms. Zaib Un Nisa. His inability to take timely and effective action reflects a serious neglect of his supervisory responsibilities. Immediate action is necessary to ensure accountability and restore trust within the team.

Therefore it is suggested that UCOO Mr. Mudasar be terminated from his position **“as per the Polio Third Party Personnel Service Rules (PTPPSR), Annex- 6: Acts to be treated as Misconduct /Sub Clause: N. “Willful Concealment of Misconduct by Another staff”**.

Hope you are well,

On 26th July, Ms. Arifa, a current CHW, filed a harassment complaint against Mr. Taymar, alleging unwanted advances, deceptive meetings, and financial demands, accompanied by threats to terminate her employment and that of her sister. Ms. Arifa also reported that other current and ex-staff face similar harassment but are unwilling to speak out due to fear of retaliation. Additionally, on 29th July 2024, a former Area Supervisor, Ms. Zarifa, accused UCPO Mr. Taymar of harassment, citing inappropriate advances and pressure to secure her position through personal favors. Despite reporting these incidents to her supervisor UCOO Mr. Mudassir no action has been taken.

Furthermore, The CTC investigation committee has conducted a comprehensive review of the harassment allegations against Mr. Taymar and investigation committee included all the victims and witnesses and Below are the committee's findings for your review and approval. Upon WHO-PO's approval, we will forward this report to WHO-FO for final approval. All relevant statements and evidence related to this case are attached to this email for your convenience.

Recommendations:

Based on the findings, it is recommended that **Mr. Taymar Mari** be terminated from his position as UCPO due to multiple violations of organizational policies, including harassment and financial misconduct, as corroborated by evidence and witness statements. His actions have compromised the safety and well-being of the staff and have breached the ethical standards expected of someone in his role **“as per the Polio Third Party Personnel Service Rules (PTPPSR) Annex – 7-B: Disciplinary Action in Case of Performance, Table 1: Disciplinary/Accountability**

Framework/Gross Misconduct - Red Line Area: Sub Clause 6: (Abuse of Authority) and Sub Clause 7: Any type of Harassment (Sexual, Discriminatory, workplace etc.)”.

Additionally, a formal warning should be issued to **UCOO Mr. Mudasar** for his lack of awareness regarding the serious issues within the UC and the challenges faced by the staff. His failure to address these problems in a timely and effective manner reflects negligence in his supervisory responsibilities. Immediate action on both fronts is necessary to ensure accountability and restore confidence within the team **“as per the Polio Third Party Personnel Service Rules (PTPPSR) Annex – 7-B: Disciplinary Action in Case of Performance/ Capacity Issues - Amber line Areas/ Clause 4: Poor supportive supervision”.**
