I have been accused of posting an inappropriate status. Since we live in a digital age, the civilized world has established principles for digital harassment as well. The allegation against me is that by posting a status, I harassed Sonia.

I would like to clarify a few things here. WhatsApp is used for three main purposes: one-on-one conversations, group chats, and statuses, which are general in nature. In statuses, people express personal thoughts, events, or ideas.

In the first case, which is one-on-one communication, only the two people involved in the conversation can see the messages. If something inappropriate is said that offends or causes distress to the other person, it falls under harassment. In my case, no such thing has happened, and the committee has personally checked my mobile chats and found no evidence of any harassment towards the complainant.

The second case involves group chats on WhatsApp, where various people communicate together. I did not mention the complainant in any group chat in a way that was unpleasant or could be considered harassment.



Now, let's discuss the status, which is the basis for the harassment allegation against me.

As you know, statuses on WhatsApp can be viewed by all contacts saved on your phone. It's up to the viewer to decide what they want to see or ignore. There is a filtration system available that allows users to filter content they do not wish to view. They are not obligated to view anyone's status.

Similarly, I have over a thousand contacts saved on my phone. I, too, have filtered out many people's statuses, and many people do not see my statuses either.

Now, let's get specific. The complainant has based her allegation on viewing my status. This allegation would only hold if I had mentioned her by name or referred to her in some way in my status. The fact that many other people also viewed this status shows that I did not harass anyone, including the complainant, as I did not mention anyone by name. If the complainant can prove that I mentioned her directly, then I am indeed guilty and deserve punishment.

#### 2.misbeahvior

As you're aware, we are currently working on an emergency program. During the last session, our UC PCM encountered some issues, which unfortunately led to increased pressure from higher authorities.

In light of the situation, my tone may have been perceived as elevated. However, I immediately addressed the matter by refocusing everyone on their respective responsibilities to ensure the work continued smoothly. I am sure it was not intensionaly.

If you are not fully satisfied with my explanation, I welcome you to further investigate my professional conduct. Please feel free to speak with the relevant staff, including UCOO, CBO, AS, CMs, and CHWs.
