I am CHW Rabia somedays ago one problem occurs to me, which I told CTC about. But after some times the issue was resolve. Now I am facing that UCOO Nizam is being personal with me from quit some time. He called CHW Rehana to BHU and force fully make her write a letter. On which she wrote, "I will accept all my fault and I will never do it again". I have all the evidence of it. I will give it to CTC. He did admit that I made the issue of Rabia and I will do it again too. He told CHW Rehana to make a distance from me. I have compliant against UCOO Nizam why is being personal with me. He called me on the contract distributions day and ask me did you go CTC against me? and if you really did nether it will make any impact on my health nor it disturbed my sleep. It will just make you distress to go their again and again. It is just a rubbish situation just ended it here. In this I told him sir I just finish this all matter right you are the one who is starching it. In which he passes the remarks, I think your mental state is not okay. Or maybe you are very beloved to your husband's and In-laws that's the reason you are so upfront. After that on the day of Micro census, we told him that I and Rehana are working together and he said he is tolly fine with it he just needed the work. But after that he start mentioning the issues in Rehana Area even though they are not any. Once he asked all our teams to kit station to work on a book but after few days Rehana told me she asks to come in the BHU for book checking. But when she went their only, she who is asked to come out of all the CHW. Then in the presence of AS Bilgees and AS Haseena. They take her to the separate room and force her to write the letter I mention early. Even though that issue is between me and AS Husnaa Team CHW Sadia. Rehana has no involvement in this. Even after that AS Bilgees I do not thing Rehana can say something like that but As Hussan said she herself told me that Sadia is Widow. When Rehana Refused to write the apology letter, when AS Hussan talks with her very harshly that you are same girl in the Abdullah Lodhi case. She even slaps the door. In the night, 07:45pm UCOO Nizam called Rehana and I will provide you with the recording. After all that issues sir stats reporting me, and once he reports me in the thing which I told him by myself that I start working from the next street. For this mistake I got the explanation where I accept my mistake and did apology. I do not know why UCOO has an issue with my and Rehana's friendship. And why he is keep reporting me. and telling me and everyone that I will be terminated. He said my friend that I cover many of your mistakes and I will not report you. Even though I reported in minor reason then why he is supporting Rehana. My AS told me that she did not report me to Sir Nziam but when Sir Nizam came her behaviors has completely changed. And she told UCOO that this girl just screws my mind. In return, sir told her just report her and get her terminated.

There are many witnesses of these things. In addition to, my one friend called some days ago and told me CHW Sadia told UCOO Nziam that you are went to her house and create disturbance in her family. Even though I went to that team house with my other colleague.
