This was reported repeatedly AV from the last few campaigns having three children's.

If UC Incharge is giving marker to his relatives and they admit it Infront of both CBV and COMNet team, then what other staff will seek from it .

I have mentioned the detail of this family in letter attached below and request you to properly investigate it so that team may not be habitual of doing Such activities who become hindrance on vaccination of every children.

I hope you will follow it up on urgent and punish those who are involved.

It,s stated that we the following are polio workers CBV Staff /AS( SUNEELA ),CHW (NAYAB),Comnet Staff member (Naheed Alsm) are performing duties in lalazar colony near university campus .we have recovered a marker from the house 93 HH name amjid and dolat .According to the child mother statement that fahad zaman provided us the marker for fake marking the child .

The ucpo fahad himselfly is not doing his duties and coming to office daily 10 am to 11am .it has also been observed from several chws that he is recording fake clusters direct from chw,s book instead of taking it in the field same he is doing fake field validation and desk validation directly in cd islamia college aurakzae health center.

He is also doing corruption in DDM ,s recently the driver card he filled for himself by whiteneing it with whitener .he is also blacklist and poor performance in people and etc.

He also hiring transit and chw observer by own choice who is their friend relative or young beautiful which deprive the right of others.he is also not doing duty during opv campaigns staying in own house and resting for whole day their just coming for evening meeting.

Kindly take initiate an Inquiry against him for such negligence as he destroyed uc university town before and now in uc shaheen town by creating grouping in uc shaheen town.
