Dear Respectable Dr Asma, Greetings and Best Wishes for the day.

I would like to bring to your attention several concerns regarding UCPO Shakeel's attitude, field performance, and approach to supervision during the NID-FEB 2025.

Microplan and Vaccine Carrier Availability: Upon inquiry, UCPO Shakeel stated that UC-Ops does not carry Microplans (MP) in the field, and no vaccine carrier was present when DDPO visited him, stating that UC staff usually don't carry MP and vaccines. However, verification with other staff confirmed that they do have their MPs, and I had already instructed all teams via a voice note to ensure they carry them.

Team Monitoring: The monitoring of teams is inadequate, with no proper supervision of field activities. Observations suggest that he is merely present in the field to fulfill location and checklist requirements rather than actively ensuring quality implementation. Additionally, AICs under his supervision appear disorganized and lack proper coordination.

Professional Conduct: His manner of communication, particularly with female staff and monitors, is concerning. The tone and approach observed are unprofessional and unacceptable. I will document specific instances separately via email to ensure corrective measures are taken.

Building Access and Cluster Validation: UCPO Shakeel consistently refuses to enter buildings, citing a lack of access and permission from owners. This raises concerns about how he determines and validates clusters. Upon inquiry, a few FLWs reported that he asks them to bring male family members outside the buildings instead of ensuring proper cluster identification. Moreover, during the cluster validation, his cluster was found to be out of sequence, with few households found confused if he has visited them as household stated that 2 females usually visit.

Please review these concerns as this UCPO has been a problematic one with so many performance issues and field concerns, keeping in mind this UC-Chakiwara is already a low-performing UC with many operational issues, and someone non-serious like Mr. Shakeel is making it worse.

Your support in ensuring professionalism and effective field supervision is highly appreciated.
