Salam dear all colleagues.

Hope you all will be enjoying the fasting.

Dear, AC sahib, i want to bring some issues in your notice regarding the UC staff of district orakzai.

1. we have more than a dozen UC staff who have their dual houses in districts other than their home district, due to which most of time we are doubtful of their presence in home UC. When we found them absent in their home UC during our visit, we marked them absent on that particular day. Secondly, most of our UC staff have multiple clubbed UCs of their duties, which create hurdles for us in case we visit one of their UC on a particular day because they showed their presence in an other clubbed UC.

2. Lack of Communication is a also a big challenge in few UCs. This also is a big hurdle in validating presence of UC staff on daily bases. We can only validate them during our visit to that specific UC.

3. UCs Arghunja,Sama mamozai are areas which are denotified areas.We have started campaign activities in these UC on our own risk.This UCs has only about 100 target for PEI. No health infrastrucure,no health activities,no communication network is presnt.We just conduct only three days PEI activities with observing strict security measures bcz these UCs are security compromised.

In the light of abow scenarios, i request AC sahib to discuss the issue with provincial office for devising a smooth Working mechanism for UC staff. Attached is the list of UC staff having dual houses.
