With reference to the following communication it is to inform you that a joint inquiry was conducted on 29 Dec, 2020 by PTPP and CBV Project team members of CTC. The statements of complainant AS - Ms. Shekeela Ibrahim (attached as annex A), subject UCPO Mr. Khalid Waseem (Annex-B), UCDO-Mr. Zahid Ali (Annex-C) and AS - Ms. Hina Kawal (Annex-D) were recorded. UCDO Mr. Zahid Ali was the eye-witness of the incident while AS Ms. Kanwal was helping AS Ms. Shakeela in Microplan preparation when the incident took place.

After completion of the inquiry CTC team conducted meeting with DDPO-Dr. Naveed Khurshid (second line supervisor) and DDOSO-Dr. Muhammad Kamal (first line supervisor) and acquired their feedback regarding the performance and conduct of the UCPO:

- 1- During the inquiry process it was confirmed that the subject issue had been already resolved and settled down at UC level by the senior supervisors
- 2- Ms. Shakeela allegations were found baseless and false,
- 3- UCPO was not involved in any misconduct

Hence, it is recommended to conduct a counseling session with the UC staff members by PTPP and CBV team members of CTC in presence of supervisors.

Greetings

I would like share with you that last day an incident occurred at our UC, where our UCPO Mr. Khalid Waseem and AIC Ms. Shakeela Ibraheem abruptly started reasoning with one another, when I heard

shouting of Khalid Waseem and Ms. Shakeela Ibrahim I enter to room and asked the reason of the issue, but both colleagues were in aggressive mood and shouted on one another, then I request to Ms

Shakeela Ibrahim AIC for keeping calm, and set near to her for inquiring the issue, where she informed

me that I asked from Ms. Hina Kanwal about something in micro plan, and Mr Khalid Waseem told to

Ms. Hina Kanwal that do not support Shakela Ibrahim in Micro Planning, as she will prepared this Micro

plan by her self.

Our UCPO Mr. Khalid Waseem was too much in an aggressive mood and used harsh words to the Area

Supervisor and insulted her in front of all teams, which she minds and become depressed on this

insulting attitude of Mr Khalid Waseem. Later she went out from room for drinking water, but same

moment her foot slipped near water cooler and filled on ground where she received injury in her head,

I asked to FMT of BHU for checking of B.P and request to provide first aid, she comes along with M.O

and checked B.P of Shakela Ibrahim which was 160/100, they administered medical treatment like

injection and give tablets to control her B.P, she also advised rest for a while.

After some time, her situation was not recovered and B.P was continuously high as previous. Where I

called rescue 1122 for provision of Ambulance services and referred her to near City hospital for further

emergency treatment, Doctors checked her and diagnosed medical treatment of painkillers & infusions

to low down her B.P and suggested more investigation like ECG and CT Scan (Brain window). We stay

there at hospital till 02:00 PM along with two more AICs for medical checkup of Ms. Shakeela Ibraheem,

but her situation was continuously worse, and she repeatedly complaints of body pain and headache,

then we also informed her husband that Ms Shakeela B.P is very high and we are here at City hospital

for treatment. I stayed in the city hospital along with two AICs and ALSM till 02: 30 PM.

Our AIC Ms. Shakeela Ibrahim submitted a written complaint to UCDO today against Mr. Khalid Waseem

and complained about his harsh attitude. Therefore, I am forwarding her grievance / written statement

for your kind consideration and further investigation.
