

Employment Contract

THIS AGREEMENT made as of Feb 1st, 2019, at Islamabad between CHIP Training and Consulting (Pvt) Ltd (hereinafter referred to as Employer) having its principal place of business at Islamabad and Mr. Hammad Ullah (hereinafter referred to as Employee), Kumb – Kashmore – Kashmore – Sindh. WHEREAS the Employer desires to obtain the benefit of the services of the Employee, and the Employee desires to render such services on the terms and conditions set forth.

IN CONSIDERATION of the promises and goods and valuable consideration the parties agree as follows:

1. Position Title

- (a) The employee shall be designated as **Union Council Polio Officer (UCPO)** for Polio Third party personnel (PTPP) as part of Polio Eradication Initiative (PEI) in Pakistan.
- (b) The employee shall be required to perform his/her duties as per TORs.

2. Contract Validity

The employment contract will be valid from Feb 1st, 2019 to Apr 30th, 2019 and will be considered discontinued if not extended expressly.

3. Duty Station & Reporting Line

The employee shall be based in Kumb - Kashmore - Kashmore - Sindh and shall be reporting directly to the concerned Distrct Polio eradication officer (DPEO) with close coordination of both WHO Area Coordinator and Provincial WHO Team for all day to day/program activities.

Salary

- (a) Basic salary including medical allowance of PKR. 50,400/- per month shall be paid.
- (b) It will essentially remain the responsibility of the employee to keep his/her tax affairs in order i.e obtaining NTN and filing tax returns. By accepting this employment, the employee has categorically exonerated the employer from any responsibility of his/her tax affairs.
