Later CHW was referred to THQ Khanozai and provided first aid' dressing and anti rabies first dose.

Further her today target was achieved by a reserve pool candidate and reserve pool candidate will work with us till the end of NID Oct, 2023 campaign' CTC office permission is required in this regard. Reserve pool candidate CNIC copy will be provided to CTC focal person.

Because our CHW was badly injured and she is unable to work with us in the running campaign days' advised by MS THQ Khanozai Dr Habib Ur Rehman on verbal statement.

Further CHW's guardian was sensitized to keep continue treatment and also provide complete anti rabies vaccine course on prescribed schedule.

After complete treatment and anti rabies vaccine course' all the medical reports along with expense sheet will be submitted to CTC focal person for fund reimbursement.
