As verbally discussed with your good-self, this is to request your formal approval to relocate currently working District Data Usage & Risk Assessment Officer to the position of Provincial Data Officer in Quetta.

That individual would be now relocated to Provincial Level since he possesses a good work experience as per the demand of the program, secondly the position of District Data Usage & Risk Assessment is only one position across the CBV provinces. Therefore, after we relocate this individual to the position of Provincial Data Officer we may abolish the district level position later, if management decides it.

The Provincial Team Lead Balochistan has reviewed and requested for this relocation after the position of Provincial Data Officer is vacated on 31st Jan 2024.
