Reference to below email from KPK for hiring of 2 TPO positions in North Waziristan and Bannu on urgent basis, we seek your guidance and approval:

- The Polio operation of UCPO/TPO has been stopped in DG Khan, 1 Position of TPO is suggested to move from DG Khan to North Waziristan, KP. (Email from WHO Punjab Office is also attached). Kindly share your formal consent on this request for onward sharing with CTC to update their data base.
- Secondly, KP team has requested to fill above TPO position of Miran shah, North Waziristan by placing the **redundant TCSP Mr Azad Gul on board** (*when CTC conducted recruitment process in March 2021 then he was recommended as option 1 but at that time we were entertaining the redundant UCPOs only*). We need your advice against this selection.

- Also KP team has identified vacant position of TPO in Sub-Division Wazir, Bannu, for which **redundant TCSP Mr Rasool Jan** is recommended (*when CTC conducted recruitment process in March 2021 then he was recommended as option 1 but at that time we were entertaining the redundant UCPOs only*).
