Day 1 monitoring done in UC Rashakei, Charsadda

## Following issues noted

- 1. A8T3 was a volunteer female team having no route map, missed children from 3HH not written on back of tallysheet with other mistake in filling, ordinary ILR with water with no street vaccination. Concerned AIC volunteer said everything OK with team and had no team compilation sheets.
- 2. A9T2 was a volunteer female team having no route map, no info on VVM, zero dose, AV or street children B. Team doesn't have anything written in zero dose(though no routine/outreach done by anyone here), street vaccination. As per AIC volunteer, everything was OK with team having no team monitoring forms. AIC also have no vaccine vial.
- 3. A10T3 was female LHW(from Mohmand) team which has no route map with no street children, no newborn and no zero dose recording. No info on AV by team. Some NA recorded doesn't match with

- tallysheet filled in front. AIC volunteer again said all teams OK with no team monitoring formats. Previous AIC LHS, changed her into team member. 6/10 AICs in this UC are volunteers with turn over.
- 4. Fix sites at BHU Akrab daag checked. Upec Rashakei-2 present but mostly at facility without any field activity. Ordinary ILR at facility present with stabilizer but electricity 4/24 hours. Epi tech yet to be deployed. I waited for teams to come for evening meeting but none came.
- 5. Fix site at BHU Daman checked. Evening meeting with staff done. 7/10 AICs doesn't have any team monitoring forms. TTM too doesn't have any team monitoring forms. Upec chair Rashakei 1 was not seen but district said that he came.
- 6. UCPO Izhar performance is good but remaining UC level partner staff(UCPO Iftikhar, TTM and UCCO) doesn't have any operational issues and are portraying green picture just like AICs. Many issues in team tallysheet found during evening meeting, which should have been identified by UC level partner staff before.
- 7. Protest by local people in Dalazak village A4T5 protesting vaccination linking to Peshawar incident. Though team finished work and was returning. Issues reported to dpcr.

## Recommendations:

- 1. Upec Rashakei 1 to be replaced with a competent doctor.
- 2. AICs should be given warning to report issues rather than giving green picture
- 3. UC level partner staff(UCPO Iftikhar and UCCO) to be given warning. They have to report issues rather than hiding them.
- 4. Govt accountable AICs to be searched rather than volunteer 6/10 AICs having high turn over
- 5. Day 2 visit by Epi coord and PEO can be done
- 6. Upec chair Rashakei 2 to be intimidated to start supervision in field. LHS Rashakei 2 need explanation as to why switch to team member despite need of Govt accountable AICs
- 7. DC evening meeting finished early due to locals coming to DHQ regarding Peshawar rumors
