The reply of Miss.Rana Maroof UCPO of UC Spinkhak to her explanation is NOT satisfactory, if she was performing so many activities mentioned by her good self we would not be compelled to call her explanation & document it;

- 1. She has mentioned one AFP case which is baseless, in the month of June no AFP case by her good self, one AFP case Epid number PAK/KP/32/20/063 was from UC Spinkhak which was notified by EPI (TSV) and investigated by me, and at the time of investigation I haven't seen her as she was absent and was making lame excuses as she was not present in her duty station UC.
- 2. She has mentioned good support in AFP surveillance but it is the status of her support that I assigned her to monitor the stool specimens collection process but due to her negligence and lethargic approach 2 specimen of contacts were collected instead of 3 samples for inadequate AFP case but she didn't bother to visit, monitor and guide the parents.
- 3. She has mentioned to rectified 95% issues of UC level MP which is baseless, If she would have been rectified such a major percentage of issue then her assigned UC MP haven't been failed by scoring 57%, issues/gaps were rectified which was by Dr. Muhammad Gul Sartaj special monitor deployed from DPCR to her UC for poor performance in MP, even though TTM assigned to her UC is more competent than her, doing his efforts in validation of UC level MP.
- 4. She has mentioned many activities she is performing which is baseless as being 1st line supervisor she has not been shared any of the activities in the form of weekly report or monthly progress report with me.
- 5. She has been found absent from her assigned UC during my and visit by PEO Dr. Gul Sartaj, as in the month of June I visited twice her UC for investigation of AFP case and second time for the collection of stool specimens but I haven't seen her physically nor in the UC health facility nor in the field, how she claims to be present there, then on contacting first she did'nt bother to communicate snd while she was contacted was making lame excuses but in actual she was absent and not present in her UC.

In short I request CTC team and our seniors to guide her to improve her performance for the National Cause and Emergency PEI program inspite of making lame excuses and putting baseless activities on her behalf.
