With reference to below email a show cause notice has been issued to UCPO Mr. Muhammad Usman on account of dual job. As per his response he has been appointed as an Arbic Teacher at G.M.S Pash Ziarat. However, he has not joined his new job position due current situation of COVID-19. Further Education department has issued a notification dated 2nd July, 2020 that salaries of newly appointed staff will be on hold. Therefore, he requested to withdraw a show cause notice, when he will join his new position he will server prior notice period. (*his response and education department notification copy is attached as Annex-A and B*)

In order to investigation the case CTC issued a letter to DEO office Wazir-S for verification of his job status. In response they shared his appointment order and hand over the charge of responsibility report with CTC office. *(both evidences are attached as Annnex-C and D)*

According to the evidences, he has been appointed on dated 17 April, 2020 and has signed the charge report dated 18 April 2020. However, the schools are closed therefore he has not joined his duty. He will receive his salary from government w.e.f 17th April 2020 in arrears.

His response to the show cause notice is considered unsatisfactory. He has concealed his new job status from the organization which fall under Red line area and marked for zero tolerance.

He is recommended for termination of contract on immediate basis.
