I Hope you will be fine and Healthy.As You Know that Khyber is the most infected part of Country for polio virus.More then 15 CVDPV2 cases reported from Khyber in last year or so.To stop this circulation NEOC decided to conduct campaign in khyber and other parts of Country from 13 August.As your good self well aware that preparation of Microplan and its Validation is one of the most important part of campaign,without which a successful campaign can't be conducted.

When DEOC assigned a task to me Of revaildation of microplan of Mastak,it came to my knowledge that that no area Level or UC level microplan were validated by UC level Staff(**UCDOs Muntazir and Abdus salam and UCPO ahmad**) the same was also accepted by UC level staff when asked telephonically.

More over Mutazir went to test and interview of UCCO with out Information and was Absent from field during last week(pre campaign activities phase)for more then 3 days.

Abdus salam also didnt Inform his Supervisor prior before coming to Peshawar for personal work.

In all above scenario UCPO Ahmad failed to Fullfill his responsibility of either reporting them to senior level or taking any corrective measures by himself.

Attached Please find area level microplan which hasnt been validated till last day before campaign.

Therefore As District Delivery Opertion and Supervision Officer for Khyber,I am recommending all three for strict disciplinary action in order to streamline campaign activities in High risk UC like Mastak.
