However, he has not visited this village for the last one year and have not taken clusters. Which shows his lack of commitment and negligence toward his duty. Recommended for explanation letter followed by warning.
- **Mr. Wazir Ulla - UCPO Spinwam-2:** Area Supervisor of CBV team has been terminated on account of poor performance. Mr. wazir never reported his poor performance to the concern authorities and he was defending him in the whole situation. Which shows his lack of monitoring and supervision skills. Recommended for explanation letter followed by warning.
- **Mr. Haseen Ullah - UCPO Dossali-1:** Special meeting of UCPOs was arranged with National RRU team on 5th day of NID April 2019 in Miran Shah. However, he was absent from meeting without permission of his supervisor and he was conducting meeting with Nutrition team at CH Dossali. Which shows his lack of interest and neglect of duty. Recommended for explanation letter followed by warning with one day salary cut.
