This is to bring to your kind attention and necessary approval for the Termination of Mr. Shaheen Khan Abro UCPO UC -05 (City) District Shikarpur.

This is to submit that his attitude and behavior issues were continuously being observed since the past 2 months. He has been warned twice to improve his behavior and attitude problems.

Due to following issues it is to appeal for your kind approval for the termination of Mr. Shaheen Khan Abro:

- Recommendation of the termination by the Deputy Commissioner due to his unresponsive and misbehaving attitude with the Taluka Supervisor in the year 2016.
- Two warning letters have been issued based on the enquiry report and the use of inappropriate language at the ADC-1 Office.
- Irresponsible in fulfilling his duties from the past 2 campaigns in terms of the Microplan development and support. He has been giving only excuses of not having Microplan on two occasions.
- Misbehaving attitude with his Medical Officer of the assigned UC. Multiple statements were provided that the UCPO has displayed unacceptable act and has torn the attendance sheet papers during the Teams' Training.
- Use of inappropriate language with Additional Deputy Commissioner- 1 against the Medical Officer.
- Creating hindrances during the Anti-Measles campaign.
- Recommendations for the termination of the contract by the Deputy Commissioner, Additional Deputy Commissioner-1, and District Health Officer of the ongoing period.
- Asking the PEOs (Supervisors) for the official and unofficial favors, along with sending threats to file FIR based on false allegations.

- Threatening the PEO for harming the monitor TTSP during the anti-measles campaign (October 2018). Putting false allegations against the independent monitors.
- Hiding the observations of the Microplan discrepancies despite of having information.

It is once again appealed to your kind approval for the immediate termination order for Mr. Shaheen Khan Abro UCPO of City 05 Union Council of District Shikarpur.

The detailed warnings, print-out copies for the threats and emails are attached herewith this NFR.

SUBJECT: INFORMATION REGARDING THE PROBLEMS BEING CREATED BY THE UCPO OF UC-05 DURING THE ANTI-MEASLES CAMPAIGN.

Dear Sir,

I want to report and keep this in the record about a situation with you. Yesterday the UCPO of UC-05 who is under constant watch and investigation, called me on phone by around 10:00 a.m and said that as you guys have sent a person (Hubdar Ali TTSP) in my UC for monitoring, the TTSP (monitor) is misbehaving and abusing the team members of UC 05 for no reason. If PEOs will not remove that monitor of WHO from Union Council-05, he may harm the monitor physically.

To further investigate this matter, I suspended my scheduled field activities I called the TTSP and confirmed the situation to which he answered that he has not done anything like that and it can be validated by anyone. I cross verified again from the teams (Team 1 and 2) in that UC as per the statement of Mr. Shaheen, and got the same reply from the teams that no such thing (misbehaving attitude) was done by the TTSP and everything was going as normal. Indeed the TTSP has been very supportive in the field, the 2 unrecorded and unvaccinated children were also properly communicated to the teams and 1st Level Supervisor in time.


Sir, Mr. Shaheen (UCPO) is trying to throw false allegations against the monitors without any reason deliberately which is causing loss of time and efforts during the campaign, and creating issues within the team. He has been clearly instructed before not to interfere in the campaign activities as well yet he is not following the instructions.



Thank you so much for the email Honorable / Respected Sir,

decided earlier that we can not terminate any UCPO or any worker merely on the directions of the District / Administration without hearing from both sides. This issue is continuously being discussed with our immediate supervisor (Area Coordinator) "Dr. Ghulam Hussain Bulledi" and Dr. Ahmed Wahabullah is also in the loop for this. Furthermore, it was

crossed all of the limits. Our worthy Area Coordinator has also previously observed the responses from the same UCPO in the field too before him. We have even tried to resolve the matter internally, but now the UCPO has

- 1. He was issued a similar termination letter in 2016 as well, where the matter was solved with internal efforts and apologies from WHO side to the Deputy Commissioner of that time
- 2. He has also previously talked harshly with us (Both PEOs), but we solved it internally
- 3. We have supported him on numerous occassions to uplift his performance and attitude professionally and morally in his bad times as well.
- 4. We have kept informing him about the enquiry as well that it will be conducted and the action will be taken on the suggestions from higher ups.
- During enquiry, based on the statements, we found that the UCPO should be given a chance with a warning letter and not with the termination.
- 6. We issued him an explanation letter and called him to discuss out the issues. He came and discussed the whole scenario. He is also now negating those of his statements as well.
- 7. But then he started interferring in a wrong manner by stopping the measles campaign in his assigned UC due to his personal stance and brought the teams directly to the ADC-1 office. Before the worthy ADC-1, he has used inappropriate and unacceptable language against the UCMO to which ADC-1 has showed serious displeasure regarding his behaviour and has clearly directed us to stop him from going into the field in order to avoid further on-ground issues.
- 8. Afterwards, from the fear of the official action, he started alleging both of the PEOs of the mental harrassment. The UCPO has indeed started mental harrassment against both of us (PEOs). He has sent personal messages and threats for launching FIR in order to put his both supervisors under mental stress. As it has ever been suggested from the security staff, not to underestimate any minor or major threat, we have reported this to our security Unit as well.
- language to him. He has also said that Or. Sundeep Sahitia (PEO) is negative since the beginning and he is sending him threatening messages personally. On further request from the UCPO, we called him yesterday to listen to his statements second time. He refused to receive the Termination Letters by DC sahab and DHO sb as he requested in the email, in hard in the Measles campaign, to which we asked him that why he did not report that to us? to this he responded that he will report it as per his will and choice. He is also now alleging that ADC-1 has used abusive (Elackmailing stuff). He also accepted that he has used some inappropriate words against the UCMO before the ADC-1. He also said that he knew that there were Microplan issues ongoing in terms of resources copy. He also refused to receive the warning letters. He further asked to share the enquiry report. He also asked both of the PEOs to give him official and unofficial favours otherwise he will continue doing this
- 10. Our AC-WHO has also found the UCPO in the field presenting illogical and lame excuses with blames to others for the shortcomings that he has been found with during the field

This is the current development at district level Sir.

SUBJECT: REQUEST FOR THE TERMINATION OF THE UCPO OF UC-05.

A case of UCPO of UC -05 is being proposed before you for your serious consideration. Mr. Shaheen Khan Abro is working at the position of Union Council Polio Worker in UC -05 City at District Shikarpur. His attitude issues have been there since long but those were managed until now when the above said UCPO has crossed all of the limitations. Following is the sequence of the events from beginning till now.

- Mr. Shaheen (UCPO) was reported to have misbehaved with the Taluka Supervisor of
 that time period in which he was seriously suggested to be terminated by the Deputy
 Commissioner (DC) under the letter No. DPCR: 62 / 2016 dated 25.06.2016. That matter
 was solved internally when the UCPO offered apologies before the Deputy
 Commissioner (Letter copy attached).
- 2. Second major incident came into light when a complaint by the Medical Officer dated 12 / 09 / 2018 in which the Medical Officer in the same assigned UC alleged that the UCPO has used unacceptable language and has misbehaved harshly with the UCMO infront of the Team Members. Another letter for the recommendation of termination was also received from both the District Health Officer and Deputy Commissioner under the Letter No.DPCR / SHP / 145 dated 28.09.2018. Enquiry was conducted by both PEOs and it was found that UCPO has behaved harshly with the UCMO and even tore papers (attendance sheet) in front of the team members. However, it was proposed in the recommendations section to give a Warning Letter instead of termination to give him a last chance indeed (Enquiry letter attached). Another Warning letter was issued to him on the basis of enquiry to give him another chance for improvement in future ., But beside this he failed to do so.

3. On the 1st Day of the Measles campaign, another complaint was received at DPCR that Mr. Shaheen Abro again treated the MO on the same harsh pattern. Soon After that, he was asked to stop working in the field as per the directions from DC Shikarpur through DPCR channel.

4. On the 2nd day of the Measles campaign, he was reported to have stopped the work of the measles campaign in between and took all of the outreach teams to the ADC-1 office by misquoting them that ADC-1 is calling all of them. During his interaction with ADC-1, he was found using inappropriate language against the UCMO to which ADC-1 asked the UCPO to leave the office and has instructed the teams to continue working in the field while passing the directions that UCPO will no more work in the UC in order to avoid the

further obstacles.

5. Sensing a strong disciplinary action, the UCPO has now started threatening us and others by sending the Text Messages briefing that he will launch an FIR against the PEOs and other. Text Message details are "IT IS INFORM YOU THAT I AM LODGE FIR AGAINST YOU AND OTHERS. GROUNDS – MENTALLY HARRASMENT TO ME AND OTHERS FROM LAST I YEAR", while another message details are "MR SUNDEEP SAHITIA NOT MY BOSS AFTER 5 PM DUTY TIME ACCORDING TO MY TOR AND CONTRACT. I AM WAITING FOR OTHERS."

Under the light of such scenario, it has become impossible now to work with such UCPO who has started using threatening tactics and is not resolving his attitude issues not only with the district authorities but also with his immediate supervisors.

It is therefore kindly requested to you that we are endorsing the recommendation now for the termination of the UCPO of UC-05 on immediate basis in order to not worsen the situation on the ground so that the Polio Eradication Initiative activities should not be affected.

PAST HISTORY:

A letter of suggestion for the termination of the UCPO of UC -05 was received from worthy Deputy Commissioner with letter No: DPCR: 62 / 2016 dated 25 / 06 / 2016 (Annexure-4). He was previously also suggested by the previous worthy Deputy Commissioner to be terminated due to his misbehaving attitude with the Taluka Supervisor of that time. On a recent visit by the worthy Area Coordinator (WHO) during the September NID, 2018, he was also found behaving irrationally despite of not having any copy of Microplan and Vaccine Carrier with himself.

CUMULATIVE STATEMENTS:

Venue: District Polio Control Room.

Enquiry done from Area Incharges and Randomly selected Team members.

Those Area Incharges and Team members who were giving statements against the UCPO were not ready to give any statement in written due to the fear of any retaliation for the fact that they were local, even after assuring them.

Agreement: All of them agreed on one statement that UCPO was displaying aggressive behavior with the Medical Officer (Dr. Shakeel Mangi) and even tore the attendance sheet papers.

Non-agreement: Two of the Team members confirmed that the UCPO used unacceptable language while the rest of the team members (6 in number) declined such statement.

ACTIONS TAKEN:

Following a complaint received at DPCR from UCMO dated 12 / 09 / 2018, a written explanation was issued to the UCPO dated 14 / 09 / 2018 (Annexure-2) to explain his position in written form. A written response was received from the concerned UCPO dated 22 / 09 / 2018 (Annexure-3). Following the written response, an enquiry was hold against the UCPO. He will be issued a Warning Letter after the approval of the worthy Area Coordinator (WHO).

RECOMMENDATIONS:

 A Last Warning Letter may be issued against the concerned UCPO based on the enquiry and past behavioral problems.

Furthermore, the District Team will welcome any of the suggestion from divisional and provincial level as per official protocols.


