This is to present before you the case of one of our UCPOs Mr. Tanveer Doudpoto (UCPO of UC Humayoon).

After repetitive instructions and strict directions against the practice of data manipulation and misreporting, Mr. Tanveer has been found in this practice this time. The above mentioned UCPO was asked to carry out the Desk Review for the UC Humayoon in which he is assigned. On

revalidation of the Desk Review Checklist and cross verification of the Microplan, it was found that the Microplan was having serious gaps such as the worst quality of the Route Maps, and AIC supervision plan was lacking in the details e.t.c.
