Explanation against just hearsay an embarrassment for me and also spoil my reputation also. plz let me know if there is any thing else you need.

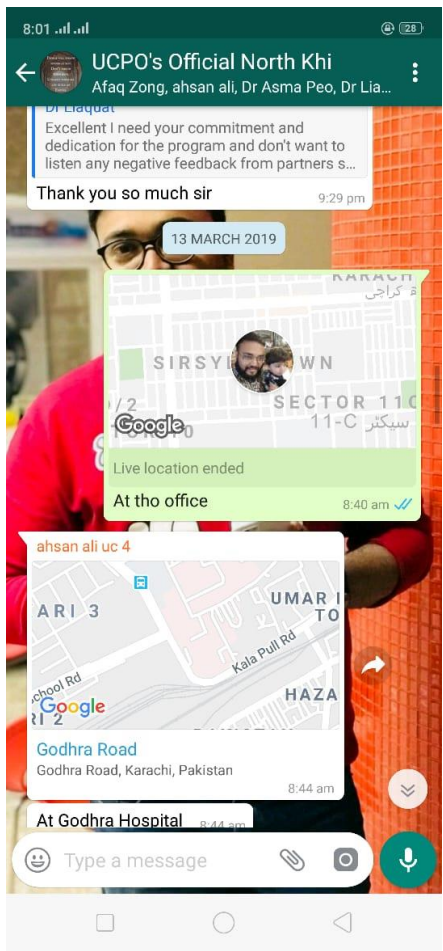

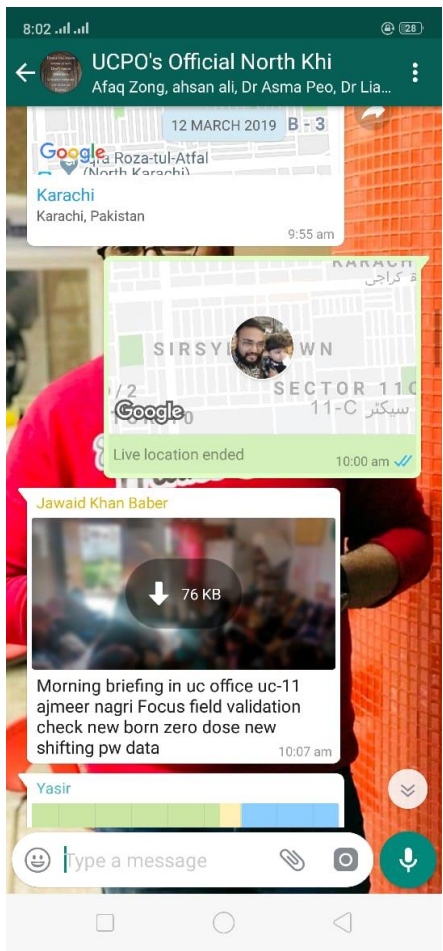

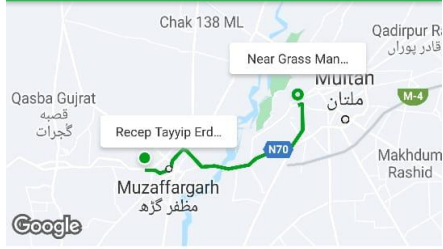
