With reference to below email a show cause notice was issued to UCPO Mr. Khan Akbar on account of reporting refusal child as NA.

In response to the show cause notice, Mr. Khan Akbar mentioned that due team clubbing in moPV2 CR campaign, sharing data on daily basis and review the data efficiently was not possible. Additionally, the issue of refusal child was reported on day 1 of campaign in UC level evening meeting (**Meeting minutes is attached as Annex-A**). However, the said children is reported mistakenly NA instead of refusal to DSC.

His supervisor feedback is also attached as Annex-B.

After reviewing his response and evidences, it clear that he has not conducted data fudging. However, his subordinates has reported refusal child as NA to DSC/IDMS, Which shows his professional negligence being a supervisor of Union Council.

Hence, keep in view his previous performance a lenient action is suggested. He is recommended for warning on account of his professional negligence.
