With reference to below email of Dr. Ghayas, Vaccine Management committee has conducted an inquiry regarding missing vials of mOPV2 of CR campaign August 2020 in UC Ghundi-A of district Khyber. A negligence in vial management has been report against UC level staff (UCDO Shah Hussain) and poor supervision of UCPO Mr. Mansoor.

As per the Vaccine Management Committee, unusable vials was not proper stored, vial physical verification and count was not done in evening on daily basis and separate zip lock bag for daily unusable vaccine with area number and name of worker was not maintained.

Hence, Mr. Mansoor UCPO is recommended for explanation letter on account of poor supervision and monitoring skills.
